Hubspot uses the Google Cloud platform in the EU (Germany) to handle the processing of personal data, but for reliability reasons the services are also hosted on Amazon Web Services in the USA. This data transfer is based on the standard contractual clauses and not on the Privacy Shield, and therefore complies with EU/EEA data protection regulations.	Voir

For example, transfers are generally based on the European Commission's standard contractual clauses. These agreements also incorporate the protections and requirements provided under Chapter V (and Article 28, where applicable) of the GDPR.	Voir
